

Several countries offer post-study work visas to international students, allowing them to gain professional experience after completing their studies. Below is an overview of some prominent destinations and their respective post-study work visa policies:

United States

- **Optional Practical Training (OPT):** Graduates can work for up to 12 months in their field of study. STEM graduates may be eligible for a 24-month extension, totaling 36 months.

2. United Kingdom

- **Graduate Route:** Allows graduates to stay and work, or look for work, for up to 2 years. PhD holders can stay for up to 3 years.

3. Canada

- **Post-Graduation Work Permit (PGWP):** Graduates can work for a period equal to their study program length, up to a maximum of 3 years.

4. Australia

- **Temporary Graduate Visa (Subclass 485):** Offers work rights for 2 to 4 years, depending on the qualification.

5. New Zealand

- **Post-Study Work Visa:** Allows graduates to work for 1 to 3 years, depending on their qualification and where they studied.

6. Germany

- **Residence Permit for Job Seekers:** Graduates can extend their residence permit for up to 18 months to seek employment related to their studies.

7. France

- **Temporary Resident Permit (Autorisation Provisoire de Séjour):** Non-EU graduates can stay for up to 1 year to look for work or start a business.

8. Ireland

- **Third Level Graduate Programme:** Allows graduates to remain in Ireland for up to 2 years to seek employment.

9. Netherlands

- **Orientation Year (Zoekjaar) Permit:** Graduates can stay for up to 1 year to find employment or start a business.

10. Singapore

- **Long-Term Visit Pass:** Graduates from recognized institutions can stay for up to 1 year to seek employment.

11. Finland

- **Extended Residence Permit:** Graduates can apply for an extended permit of up to 2 years to search for work.

12. Sweden

- **Residence Permit for Job Seeking:** Allows graduates to stay for up to 12 months to seek employment or start a business.

13. Denmark

- **Establishment Card:** Provides up to 2 years for graduates to stay and work or start a business.

14. Switzerland

- **Residence Permit for Job Seekers:** Graduates can extend their stay for up to 6 months to look for employment.

15. Malaysia

- **Employment Pass:** Graduates can apply for this pass to work in Malaysia, subject to securing employment.

16. Japan

- **Designated Activities Visa:** Allows graduates to stay for up to 1 year to seek employment.

17. South Korea

- **D-10 Job Seeker Visa:** Graduates can stay for up to 6 months to look for work.

18. China

- **Job Seeking Visa:** Allows international graduates to stay for up to 2 years to find employment.

19. United Arab Emirates

- **Job Exploration Entry Visa:** Introduced to attract young talents and skilled professionals to explore job opportunities in the UAE without requiring a host or sponsor.

20. Norway

- **Job Seeker Permit:** Graduates can stay for up to 1 year to search for employment.
